On August 28, 1984, it was discovered that Attachment B of LIS-RD-403, Unit 2 Control Rod Drive Scram Discharge Level Functional Test, was being signed off as the completed Surveillance requirements of Attachment A of LIS-RD-403. The Instrument Department surveillance procedures are being changed to a numbering system allowing for one number for each surveillance performed. The problem occurred when LIS-RD-403 Functional had two parts and two data sheets. At the time of the event, instrumentation covered by LIS-RD-01, which performs the same function on redundant switches, was within Technical Specifications. At the time of the event, LIS-RD-203 (Calibration) was within its Technical Specifications. Surveillance LIS-RD-403 was immediately performed satisfactorily; therefore, probable consequences were minimal. The second step of LIS-RD-403 has been changed to a separate procedure (LIP-RD-603).

# I. EVENT DESCRIPTION

On August 28, 1984, it was discovered that Attachment B of LIS-RD-403, Unit 2 Control Rod Drive (AA) Scram (JC) Discharge Level Functional Test, was being signed off as the completed surveillance requirements of Attachment A of LIS-RD-403. The above situation covered a period from 6/4/84 to 8/28/84. Attachment A covers the monthly Technical Specification requirements for the CRD Scram Discharge Volume High Level Differential Pressure switches. Attachment B covers a Station Nuclear Engineering Department (SNED) directive to perform a sensing line check following each scram.

## II. CAUSE

All Instrument Department Surveillance procedures are being changed to a numbering system which has a distinct number for the procedure for each surveillance performed. The surveillance in question (Functional LIS-RD-403) was broken down into two steps with two independent data sheet attachments with the same LIS-RD-403 number (one to cover the Technical Specification requirement and the other for the SNED directive for an after-scram sensing line check). This situation provided for one surveillance number with two test data sheet attachments. When the sensing line check LIS-RD-403, Attachment B, came across the Surveillance Coordinator's desk, the Surveillance Functional requirement was signed off complete.

## III. PROBABLE CONSEQUENCES OF THE OCCURRENCE

At the time of the event, instrumentation covered by Surveillance LIS-RD-01, which performs the same function for the Scram Discharge Volume Float switches as does LIS-RD-403 for the Differential Pressure switches, was within its required Technical Specification requirements.

At the time of the event, the instrumentation covered by LIS-RD-203 (Calibration of the Differential Pressure switches) was within its required Technical Specification requirements.

Surveillance LIS-RD-403 was immediately performed satisfactorily, therefore probable consequences were minimal.

#### IV. CORRECTIVE ACTION

The second step for LIS-RD-403 has been changed to a non-Technical Specification procedure, LIP-RD-603. This will allow only one data sheet to cover LIS-RD-403. The Instrument Department Surveillances have been reviewed to ensure that this was a unique, one-time situation. Review and procedure change was completed on 9/7/84.
