This refers to the routine inspection conducted by Mr. G. A. Walton of this office on June 1 - July 23, 1984, at the Beaver Valley Power Station, Unit 2, Shippingport, Pennsylvania of activities authorized by NRC License No. CPPR-105 and to the discussions of our findings held by Mr. Walton with Mr. C. Ewing and other members of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, no violations were observed.

We acknowledge your letter dated June 27, 1984, which provides additional information pertaining to violation 82-01-01 and disposition of the subject pipe to fitting welds discussed in that violation. When the additional information is received that you committed to in your response, we will perform a review and advise on disposition of this matter.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter. Such application must be consistent with the requirements of 10 CFR 2.790(b)(1).
