
Subject: NRC:RI Inspection 50-317/85-01, 50-318/85-01

This transmits the December 18, 1984 - January 22, 1985 resident inspection findings by Messrs. T. Foley and D. Trimble at the Calvert Cliffs Nuclear Power Plant, Lusby, Maryland. Those findings were based on observation of activities, interviews, independent measurements, and document reviews, and have been discussed with Mr. Russell of your staff.

An apparent violation of NRC requirements, concerning failure to barricade and post a high radiation area, is cited in Appendix A and categorized under the revised NRC Enforcement Policy, 10 CFR 2 Appendix C (47FR9987, March 8, 1984). A reply is required in accordance with Appendix A. The requirement that you reply is exempt from clearance by the Office of Management and Budget under the Paperwork Reduction Act of 1980, PL 96-511.
