SUBJECT: SUMMARY OF OCTOBER 17, 1984 MEETING WITH AP&L REGARDING INADEQUATE CORE COOLING (ICC) MONITORING SYSTEM

A meeting was held on October 17, 1984 at the NRC offices in Bethesda, Maryland. The purpose of the meeting was to discuss the installation schedule, project status, and test results related to the ICC monitoring system at ANO-2. A list of attendees is enclosed.

The NRC staff indicated that the test data which were submitted by letter dated August 30, 1984 demonstrate that the proposed design concept of the Technology for Energy Corporation (TEC) ICC monitoring system which will be installed at ANO-2 is acceptable to the NRC staff. However, final approval of this system is contingent on staff review of the final design report which is expected to be submitted in January 1985.

With respect to the installation schedule and project status, the licensee reiterated its commitment to install the ICC monitoring system at ANO-2 during the upcoming outage which is expected to begin in March 1985.

The staff also provided their comments on the final test report of August 30, 1984. In light of these comments, the licensee agreed to expand the test report in the following areas:

- Basis for selecting certain test parameters
- Basis for selecting certain sensor types
- Better presentation and explanation of test data
- Better definition for capabilities of various sensor types.
