This refers to the inspection conducted by Messrs. R. Smith and B. Breslau of this office during the period October 1-12, 1984, of activities authorized by NRC Construction Permit CPPR-147 for the Wolf Creek Generating Station, and to the discussion of our findings with Mr. F T. Rhodes, and other members of your staff at the conclusion of the inspection.

Areas examined during the inspection included review and witness of control room operations, preoperational test and testing, and review of completed preoperational tests. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspectors. These findings are documented in the enclosed inspection report.

During this inspection, it was found that certain of your activities were in violation of NRC requirements. Consequently, you are required to respond to this viclation, in writing, in accordance with the provisions of Section 2.201 of the NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations. Your response should be based on the specifics contained in the Notice of Violation enclosed with this letter.
