Operating License Review Fee Shoreham Nuclear Power Station - Unit 1 Docket No. 50-322

Dear Mr. Barry:

We received the Operating License review fee bill via the referenced letter with a due date of March 11, 1985. While we understand the fee has been assessed in accordance with 10 CFR 170, and the maximum fee (\$3,077,400.00) has been charged, we cannot determine if the costs and fee is appropriate or not.

The referenced invoice fails to provide any details associated with the stated OL review costs of \$4,172,350.00, through June 23, 1984. Prior to acceptance and remittance we need an explanation of costs in order to assure ourselves that they are appropriate as we must do under the New York State Public Service Commission's regulations.

Additionally, 10 CFR 170.21, footnote 2, states in part that the licensee "... will be given credit for the part application fee at the time the first bill is issued ... The referenced bill does not appear to give credit for the original application fee.
