"ARTICLE VIII OVERHEAD/GENERAL AND ADMINISTRATIVE RATES

A. The contractor shall be reimbursed for allowable indirect costs hereunder at a final engineering overhead rate of 89.4% of direct labor costs in FY82 and 84.9% of direct labor costs in FY83. The contractor shall also be reimbursed at a final fringe benefit rate of 38.9% of direct labor costs in FY82 and 39.7% of direct labor costs in FY83.
