SUBJECT: SUMMARY OF AUGUST 5, 1992, MEETING WITH REPRESENTATIVES OF VERMONT

YANKEE NUCLEAR POWER CORPORATION AND YANKEE ATOMIC ELECTRIC

COMPANY

On August 5, 1992, pursuant to notice, the NRC staff met with representatives of Vermont Yankee Nuclear Power Corporation (VY) and Yankee Atomic Electric Company (YAEC) at Rockville, Maryland, to discuss licensing issues related to the Vermont Yankee Nuclear Power Station. A list of attendees and a copy of each handout provided at the meeting are enclosed.

YAEC indicates that it is preparing to conduct the fuel analysis for the next fuel cycle for VY, and that the fuel being analyzed has already been ordered. The analysis will include application of the FROSSTEY II fuel performance code to loss-of-coolant accident and transient analyses. The staff and the licensee discussed remaining issues in connection with approval of the code for these applications. The staff stated expected conditions on the approval of the code for the transient analysis.

The staff and the licensee discussed the licensee's proposed Technical Specification (TS) Change No. 147 regarding anticipated transient without scram (ATWS) and alternate rod insertion (ARI). The staff saw no initial objections to the change and the licensee will provide the staff with updated amended TS pages.

The staff indicated that initial reviews of the licensee's submittals regarding 10 CFR 20.302 (RAI response) and station blackout revealed no significant problems.

The staff stressed its position regarding the need for incorporation into the TS of the licensee's programs related to intergranular stress corrosion cracking (Generic Letter 88-01). The licensee committed to meet the schedule for submitting a proposed TS change on this subject.

The staff looked at a preliminary draft response to the recent Safety Evaluation of the Vermont Yankee Inservice Testing Program Relief Requests from Vermont Yankee. The staff will review upon formal submittal.

9208143214 920812 PDR ADDCK 05000271 Requirements for retention of quality assurance records for use of computer codes were discussed. The issue was raised during a recent inspection at Vermont Yankee under 10 CFR 50.59. A determination of further staff action is required.

Administrative Change

## Status

To NRC per BVY 89-44, dated May 12, 1989. Federal Register Notice June 28, 1989. Approval needed to add to Tech. Specs. the new equivalency formula for enriched boron solution to satisfy 10CFR50.62 ATWS requirements, thus making Tech. Spec. requirements compatible with plant procedures. NRC review underway as of March, 1991. By letter dated June 5, 1992, NRC requested additional information regarding the SLC portion of this change and rejected the ARI portion due to NRC position on ATWS diversity. A meeting is scheduled for 8/5/92 at NRC to discuss resolution.

To NRC per BVY 91-125, dated December 27, 1991. Proposed change to delete specific managerial titles for composition of PORC, and to restore a previous IST surveillance item inadvertently deleted in recently issued Amendment 128. Verbal communications held between VY and NRC reviewer regarding definition of a PORC quorum as currently defined in TS. VY has proposed an alternative definition. By letters dated 7/21/92, the PORC-related changes have been denied and the IST-related change has been approved by NRC.

ATWS/ARI Diversity Exemption Request

To NRC per BVY 91-113, dated November 18, 1991. Requests permission to leave in place contaminated soil and fill material below plant buildings and structures as a result of the chemistry lab. sink drain line failure. NRC comments to VY on 2/18/92. VY responses and a revised permit application submitted to NRC on 7/10/92.

To NRC per BVY 92-03, dated January 17, 1992. Requests an exemption from the diversity requirements of 10CFR50.62(c)(3), pursuant to the provisions of 10CFR50.12(a)(2)(iii). NRC denied the exemption request on 4/16/92. Based upon discussions with NRC staff during a meeting on 6/10/92 at NRC, VY is preparing and plans to submit a revised exemption request which specifically addresses NRC's basis for rejection of the original submittal.
