

The PGP includes a plant-specific writer's guide and descriptions of our training, verification, and validation programs. The Westinghouse Owners' Group Emergency Response Guidelines, Revision 1, were used to develop the Emergency Operating Procedures (EOPs). The attached PGP describes how the EOPs were developed from these generic technical guidelines and includes justifications for all deviations from these generic technical guidelines.

The EOP Validation Program described in Attachment No. 4 may need to be revised due to potential changes in our schedule to implement a Safety Parameter Display System.
