 "Operator Licensing National Examination Schedule"

Dear Sir:

Generic Letter 91-12, "Operator Licensing National Examination Schedule," dated August 27, 1991, requested licensees to voluntarily submit updated schedules for licensed operator examinations. Philadelphia Electric Company's (PECo's) response to GL 91-12, dated October 15, 1991, included the proposed schedule for licensed operator examinations at Limerick Generating Station (LGS), Units 1 and 2.

Attached is a revised response for LGS, Units 1 and 2, to GL 91-12, Enclosure 2, "Proposed Requalification Examination Schedule." This revised response changes the scheduled requalification examination dates for LGS reactor operators and senior reactor operators for 1993 from the weeks of January 11, 1993 through February 15, 1993 to the weeks of April 26, 1993 through May 31, 1993. This schedule change does not affect the requalification examination dates for the senior reactor operators limited to fuel handling.

This schedule change results from an adjustment in the outage schedule for LGS Unit 2 caused by a higher than expected capacity factor. This shift placed the LGS 1993 requalification examinations within the outage time period, necessitating the rescheduling of the examinations in order to avoid adversely impacting outage activities.

The requalification examinations as rescheduled comply with requirements of 10CFR55 for conducting an annual operating examination. As discussed with Mr. D. Florek of NRC Region I on July 13, 1992, biennial written requalification examinations for LGS licensed operators were conducted in January 1992, and are not required until January 1994. Additionally, as discussed with Mr. Florek, no NRC administered requalification examinations are required to be conducted at LGS in 1993. Thus, conducting requalification examinations at LGS in April 1993 does not adversely impact NRC Region I resources.

Should the results of this evaluation affect examination scheduling subsequent to 1993 or impact the National Examination Schedule for LGS, the NRC will be notified.
