This transmits the August 21 - September 25, 1984 resident inspection findings by Messrs. T. Foley and D. Trimble at the Calvert Cliffs Nuclear Power Plant, Lusby, Maryland. Those findings were based on observation of activities, interviews, independent measurements, and document reviews, and have been discussed with Mr. Russell of your staff.

Apparent violations of NRC requirements are cited in Appendix A and categorized under the revised NRC Enforcement Policy, 10 CFR 2 Appendix C (47FR9987, March 8, 1984). A reply is required in accordance with Appendix A. The requirement that you reply is exempt from clearance by the Office of Management and Budget under the Paperwork Reduction Act of 1980, PL 96-511.

This inspection also found (Report Detail 4.d) no apparent consideration of the potential for an unreviewed safety question when temporary changes are made to non-safety-related systems described in the Final Safety Analysis Report and addressed by 10 CFR 50.59. Our review of this matter is ongoing and will focus on whether safety-significant functions may be impacted.
