This refers to the routine inspection conducted by Mr. J. R. White of this office on January 29, 1985 at Three Mile Island, Unit-1 of activities authorized by NRC License No. DPR-50 and to the discussions of our findings held by Mr. J. R. White with Mr. George A. Kuehn of your staff at the conclusion of the inspection.

The purpose of this inspection was to review worker allegations relative to the licensee radiological controls implemented for certain steam generator tasks.

As was alleged, the findings of this inspection indicate poor judgment on the part of the licensee in evaluating the radiological hazards associated with the steam generator eddy current probe removal task, and effecting adequate radiological controls. While such findings are indicative of a violation of NRC requirements, a Notice of Violation will not be issued in this instance since this violation meets all of the criteria specified in 10 CFR 2, Appendix C for licensee self-identified and corrected deficiencies. However, the licensee is requested to submit to this office, within 25 days from the date of this letter, a plan for corrective action follow-up as expressed in this report.


