Dear Mr. Denton:

In a letter from O. W. Dixon, Jr. to H. R. Denton, dated January 27, 1984, South Carolina Electric and Gas Company (SCE&G) indicated that Westinghouse was evaluating the results of the feedwater inlet pressure monitoring performed at the Virgil C. Summer Nuclear Station on the D-3 steam generators. The letter stated that upon completion of this review, the final monitoring report would be forwarded to the NRC. This review is now complete and SCE&G hereby submits five (5) copies each of the Westinghouse Proprietary Class 2 and Class 3 versions of the "Analysis of Virgil C. Summer Feedwater Pressure Pulsations Concerning Fatigue Usage of the D2/D3 Preheater Modification."

This submittal contains information proprietary to Westinghouse Electric Corporation and is supported by the enclosed affidavit signed by Westinghouse. The affidavit sets forth the basis on which the information may be withheld from public disclosure by the Commission and addresses with specificity the considerations listed in paragraph (b)(4) of Section 2.790 of the Code of Federal Regulations (CFR).

Accordingly, it is respectfully requested that the information which is proprietary to Westinghouse be withheld from public disclosure in accordance with 10 CFR Section 2.790. 
