This refers to the routine safety inspection conducted by Mr. P. Clemons of this office on October 2-5, 1984 of activities authorized by NRC License No. DPR-64 and to the discussions of our findings held by Mr. Clemons with you and other members of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter.
