## FUEL FACILITY SAFEGUARDS INSPECTION - OPERATIONS PHASE, INSPECTION OF SNM AND IRRADIATED FUEL IN TRANSIT, AND IMPORT-EXPORT LICENSES

2685-01 PURPOSE

This manual chapter defines the inspection program applicable to the subject licensees.

- 2685-02 OBJECTIVES
  - 021 To identify specific inspection procedures which are to be used in the program.
  - 022 To establish the frequencies of use for specific inspection procedures.

#### 2685-03 DEFINITIONS

The symbols used in Exhibits regarding inspection frequencies are as follows:

- 031 Q = Quarterly
- 032 S = Semiannually
- 033 A = Annually
- 034 B = Biennially
- 035 T = Triennially
- 036 W = When required
- 037 X = Each inspection trip
- 038 E = When such inspection coincides with other inspection activity or as events and licensee performance dictate (no specified frequency)

# 2685-05 INTER-REGIONAL COORDINATION

On shipments which involve more than one Region, the Region receiving the advance notice, and/or subsequent changes, shall ensure that other regions involved in the shipment are provided copies of the notice. Each Region is

<sup>\*</sup>The Part 8100 procedures dated December 31, 1981 and listed in Exhibits 1 through 7, define the physical protection inspection program. These procedures are scheduled for revision over the next two years to convert them to the new format defined in IE 0020.

responsible for monitoring the progress of the shipment\*\* and for implementing the inspection requirements within its own region. Separate inspection reports will be prepared addressing the inspection activity performed by each region involved in the shipment. For purposes of 766 data entry, the dummy docket number 99990080 will be used for all transportation inspections. The inspection report will be sequentially numbered by region. During the course of a shipment, the Movement Control Center (wherever located) may be inspected by any Region. When scheduling an inspection of the Movement Center, the other regions involved in the shipment shall be advised.

<sup>\*\*</sup>The progress of the shipment can be monitored by telephone contact with the Movement Control Center; however, because the information must be protected against unauthorized disclosure, the shipment progress must be discussed in terms of advance or delay relative to the schedule provided in the advance notification.
