SUBJECT: NRC INSPECTION REPORT NOs. 50-445/92-28; 50-446/92-28

This refers to the inspection conducted by Mr. W. M. McNeill of this office on July 27-30, 1992. The inspection included a review of activities authorized for your Comanche Peak Steam Electric Station, Units 1 and 2 facility. At the conclusion of the inspection, the findings were discussed with you and those members of your staff identified in the enclosed report.

Areas examined during the inspection are identified in the report. These included the quality assurance program for design changes and modifications.

During this inspection, it was found that certain of your activities were in violation of NRC requirements. However, in accordance with Section VII.B.1 of the NRC's Enforcement Policy, no citation is being issued for the violation described in paragraph 2.2 of the enclosed inspection report.
