Subject: Inspection No. 50-219/84-21

This refers to the routine safety inspection conducted by Mr. A. Krasopoulos of this office on July 23-27, 1984, at Oyster Creek Nuclear Generating Station, Forked River, New Jersey, of activities authorized by NRC License No. DPR-16 and to the discussions of our findings held by Mr. Krasopoulos and yourself at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Our inspector also verified the steps you have taken to correct the violation brought to your attention in the enclosure to our letter dated December 5, 1983. We have no further questions regarding your action at this time.

Within the scope of this inspection, items of noncompliance were not observed, however, one activity appears to be a deviation from the Fire Protection Report - Comparison to Standard Review Plan 9.5.1, Appendix A, transmitted to NRC Office of Nuclear Reactor Regulation via Letter No. EATJM-146 dated December 3, 1976. You are requested to inform this office within 30 days of the receipt of this letter of actions taken or planned to address the deviation identified in Appendix A.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter. Such application must be consistent with the requirements of 2.790(b)(1). The telephone notification of your intent to request withholding, or any request for an extension of the 10-day period which you believe necessary, should be made to the Supervisor, Files, Mail and Records, USNRC Region I, at (215) 337-5223.
