This letter provides information in response to your letter of June 6, 1984, which transmitted Inspection Report 50-416/84-08, and subsequent conversations with members of your staff.

In response to questions regarding information provided to offsite agencies during emergencies, the following action is being taken:

- °Plant Emergency Plan Procedure 10-S-01-06 has been revised to specify that copies of the Followup Notification Form, which includes radiological release and monitoring information, and the GGNS Plant Status Update form will be provided to offsite agencies as the information becomes available or every 30 minutes, whichever comes first. This procedure was issued July 26, 1984. Corporate Emergency Plan Procedure 6.8 will be revised by July 30, 1984 to require this action.
- °Training will be provided the week of July 30, 1984, to communicators on use of the notification procedures.
- °A special communications drill will be conducted by August 14, 1984 to test the revised procedures to ensure the adequacy of both the procedures and the training.
- °These plans and procedures will be exercised fully during the February, 1985 Annual Radiological Emergency Preparedness Exercise.

°Plant Emergency Plan Procedure 10-S-01-06 and Corporate Emergency Plan Procedures 6.2, 6.3 & 6.4 will be revised to require verbal communication between the TSC Radiation Protection Manager or the EOF Radiation Emergency Manager, as appropriate, and the State Radiological Assessment Officer at least hourly, or sooner if plant or radiological conditions change significantly, to assure a common understanding and knowledge of such conditions so that appropriate protective actions may be recommended and implemented.

°A meeting is scheduled on August 14, 1984, to discuss additional items pertaining to selected communications during the April 11, 1984, Emergency Preparedness Exercise. Attendees at this meeting will include representatives from Mississippi Power & Light Company, Mississippi State Department of Health, and the Nuclear Regulatory Commission.
