MOTION FOR A CONTINUANCE

Intervenor Ohio Citizens for Responsible Energy ("OCRE") hereby moves that the Licensing Board continue the hearing on Issue #8 until June 3, 1985, for the reasons outlined below.

The Licensing Board has scheduled the evidentiary hearing to begin April 9. During the March 13 conference call, the Board outlined an order of hearing in which Issue #1, on emergency planning, will be heard first, followed by Issue #16, on diesel generators, and finally Issue #8, on hydrogen control. OCRE has the burden of two complex, technical issues, Issues 8 and 16, which apparently will be heard within the same 2-3 week period, without any break between hearings. It is virtually impossible, with OCRE's limited resources, to adequately prepare a case on 2 diverse, complex, and technical issues without a break between hearings.

There is also additional information needed before Issue #8 can go to hearing. Applicants and OCRE agreed to defer further

negotiations on OCRE's 13th Set of Interrogatories until the Board ruled on the motions affecting Issue #8. Since the Board has now ruled, OCRE has initiated discussions with Applicants' counsel for the purpose of inspecting and copying voluminous documents related to the ability of the Perry containment to withstand the effects of hydrogen combustion. It will take time to inspect, receive, and analyze these documents. It is very doubtful that this could be accomplished before the April 9 hearing date.

OCRE also has 4 Freedom of Information Act requests (attached hereto) pertaining to Issue #8 pending with the NRC. The information to be gained through the FOIA requests is vital for OCRE's case preparation on this issue. It is not known when the FOIA requests will be answered, or how voluminous the information provided will be.

There is in addition to these documents other items recently obtained from the Public Document Room pertaining to Issue #8. These items are voluminous and require extensive study, which cannot be accomplished before the set hearing date.

It must also be recalled that the Staff's SER on this issue will not be available until April. See letter dated March 11, 1985 to the Board from Staff counsel.

Finally, OCRE is negotiating with potential witnesses on Issue #8. Because of current commitments, one potential expert witness will not be available in April, but may be available later. In addition, OCRE needs time to negotiate with other


witnesses who have recently been identified to OCRE.

It is the policy of this agency to be solicitous of intervenors' desires for additional time for case preparation, given the disparity of resources between Applicants and Staff, on one hand, and intervenors, on the other, Southern California Edison (San Onofre Nuclear Generating Station, Units 2 & 3), ALAB-212, 7 AEC 986, 992-3 (1974).

Any delay resulting from the continuance sought will not harm any party, including Applicants, as the Commission's new hydrogen rule, 10 CFR 50.44(c)(3)(vii)(B), does not require compliance as a condition of fuel load, but rather for operation above 5% power.

Thus, granting the relief sought is just and proper and is necessary to ensure a fair hearing and complete record. OCRE prays the Board is so moved.




