Summary of Changes

The following sections of the Clinton Power Station (CPS) Physical Security Plan (PSP) were revised to delete requirements related to maintaining positive material and personnel access control to the CPS Containment during periods when frequent access is permitted. These changes were made to reflect amended 10CFR73.55, "Requirements for Physical Protection of Licensed Activities in Nuclear Power Reactors Against Radiological Sabotage," requirements regarding containment access control which became effective on October 10, 1995.

No other changes were made outside those made for the purpose as discussed above.

Section 5.2.1.6

Deleted requirement to maintain positive access control to assure that only authorized personnel and materials are permitted into containment during times of frequent containment access.
