This refers to the routine inspection conducted by George Napuda of this office on September 24 - 28, 1984 at Hope Creek Generating Station Unit 1, Hancocks Bridge, New Jersey of activities authorized by NRC License No. CPPR-120 and to the discussions of our findings held by Mr. George Napuda with Mr. A. E. Giardino and others of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspectors.
