Gentlemen:

This refers to the inspection conducted by Messrs. W. M. McNeill and I. Barnes of this office during the period February 4-8, 1985, of activities authorized by NRC Construction Permit CPPR-145 for River Bend Unit 1, and to the discussion of our findings with you and other members of your staff at the conclusion of the inspection.

This inspection was a Region IV followup to the Construction Appraisal Team's (CAT) inspection as documented in NRC Inspection Report 50-458/84-23. The scope of this inspection was to perform a more in-depth review and evaluation of the inspection findings (unresolved issues) which were identified in the report and referred to Region IV for resolution. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspectors. These findings are documented in the enclosed inspection report.

During this inspection, it was found that certain of your activities were in violation of NRC requirements. Consequently, you are required to respond to this violation, in writing, in accordance with the provisions of Section 2.201 of the NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations. Your response should be based on the specifics contained in the Notice of Violation enclosed with this letter.

The response directed by this letter and the accompanying Notice is not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, PL 96-511.
