Gentlemen:

This refers to the inspection conducted by Mr. C. A. Hackney of this office and a team of inspectors during the period January 7-11, 1985, of activities authorized by NRC Construction Permit CPPR-147 for Wolf Creek Generating Station, and to the discussion of our findings with G. Koester and other members of your staff at the conclusion of the inspection.

Areas examined during the inspection included followup on emergency preparedness appraisal deficiencies in training, organization, onsite/offsite radiological monitoring, personnel accountability, public education and information, corporate and site emergency plan and procedures, communications, and emergency response facilities. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspectors. These findings are documented in the enclosed inspection report.

During this inspection, it was found that certain of your activities appeared to deviate from a commitment made to the NRC. This item and reference to the commitment are identified in the enclosed Notice of Deviation.

Your corrective actions in response to the deviation were reviewed by the NRC inspector prior to conclusion of the inspection and, therefore, no additional response is required.

We have no further questions at this time.
