Gentlemen:

We have completed our review of the August 31, and September 27, 1984 revisions to the Point Beach Nuclear Plant Emergency Plan. Our review indicated that the changes made do not downgrade the effectiveness of your emergency plan. A letter dated February 2, 1984 from Mr. C. J. Paperiello to Mr. Sol Burstein provided the Safety Evaluation Report (SER) (Inspection Report No. 50-266/83-25 (DRMSP); 50-301/83-23(DRMSP)) which contained the staffs review/conclusions of the November 11, 1983 revision of the Point Beach Emergency Plan. This letter stated that clarifications were needed concerning various aspects of the emergency plan to close out Sections A, B, C, D, G, H, I, J, L and N of the SER. A letter dated August 21, 1984 from Mr. C. J. Paperiello to Mr. C. W. Fay transmitted Inspection Report No. 50-266/84-13(DRSS); 50-301/84-11(DRSS) which addressed each of the items requiring clarification. All but two items were adequately clarified. Therefore, all sections are closed except for Sections J and N, where further clarification is necessary as discussed in Inspection Report No. 50-266/84-13(DRSS); 50-301/84-11(DRSS).

Please be reminded that 10 CFR Part 50.54(q) requires NRC approval of any changes to your plan which may decrease the effectiveness of the plan. However, if your safety review indicates no decrease in emergency preparedness, then changes can be made without NRC approval. In all cases, you should furnish copies of each proposed change to the NRC in accordance with 10 CFR Part 50.54(q). Also, any changes to the Emergency Plan Implementing Procedures should be made in accordance with the requirements of 10 CFR Part 50, Appendix E, Section V (Implementing Procedures).
