Gentlemen:

This refers to the routine safety inspection conducted by Messrs. R. Smeenge and H. A. Walker of the Region III NRC office during the period September 10-13, September 24-28 and October 1-5, 1984, of activities authorized by NRC Construction Permit CPPR-147 for the Wolf Creek Generating Station, and to the discussion of our findings with Messrs. W. Rudolph and R. Grant, and others of your staff at the conclusion of the inspection.

Areas examined during the inspection included QA program administration, audits, document control, design changes & modifications, records, test and measuring equipment, safety committee activities and corrective action. Within these areas, the inspection consisted of a selective examination of procedures and representative records, interviews with personnel, and observations by the inspectors. These findings are documented in the enclosed inspection report.

During this inspection, it was found that certain of your activities were in violation of NRC requirements. Consequently, you are required to respond to this violation, in writing, in accordance with the provisions of Section 2.201 of the NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations. Your response should be based on the specifics contained in the Notice of Violation enclosed with this letter.

The responses directed by this letter (and the accompanying Notice) are not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, PL 96-511.
