

Pursuant to 10 CFR 50.54(p), please find attached five (5) copies of Revision 13 to the Oconee Nuclear Station Security Plan. Revision 13 reflects the recent relocation of the alarm station to the secondary alarm station located above the PAP. Door tables, drawings and plan text have been revised to reflect the relocation. Revision 13 does not decrease the effectiveness of the Oconee Nuclear Station Security Plan.
