This refers to the routine safety inspection conducted by Mr. E. H. Gray of this office on September 19-21, 1984 and September 26-28, 1984, at the Hope Creek Generating Station, Unit 1 of activities authorized by NRC License No. CPPR-120 and to the discussions of our findings held by Mr. Gray with Mr. A. Giardino of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, no violations were observed.
