SYNOPSIS

On April 5, 1995. the Office of Investigations, Region I (OI:RI), opened an investigation into concerns that New York Power Authority (NYPA) employees and/or NYPA employed contractors had been harassed and discriminated against because they had raised and pursued safety concerns regarding the Indian Point 3 Nuclear Generating Station (IP3) fire protection (FP) program.

In the separate cases of four individuals, the investigation did not substantiate that they were harassed or discriminated against because of their involvement in FP issues at IP3.
