The referenced NRC Administrative Letter (AL) requests that licensees, on a voluntary basis, provide estimates of the numbers of candidates for the operator licensing examinations for fiscal years 1996 through 1999 and the generic fundamentals examination for fiscal year 1996. The AL also requested the dates for the next scheduled licensed operator requalification examinations.

The best estimate of Duane Arnold Energy Center candidates for both operator licensing and generic fundamentals examinations is provided on the enclosed NRC Form 536. The dates of the next scheduled licensed operator requalification examinations are November 18 through December 20, 1996.


