SUBJECT: CORRECTION TO JANUARY 2, 1996 COVER LETTER FORWARDING ENFORCEMENT ACTION (EA 95-170)

On January 2, 1996, NRC issued you a Notice of Violation and Proposed Imposition of Civil Penalty. This will acknowledge receipt of your letter dated January 30, 1996 and your check for \$50,000 in payment for the civil penalty. Your corrective actions will be examined during future inspections.

As you are aware, a letter also was sent to your Director of Nuclear Security. As a result of reviewing his response, we have concluded that the January 2, 1996 cover letter needs to be corrected. He does not appear to have been involved in this matter until after the violation occurred and the contractor employee's access was revoked. This is reflected in the January 2, 1996 letter to your Director of Nuclear Security but not in the January 2, 1996 letter to you. Our concern with his performance was that he supported the access decisions that had been made in this matter which were not in compliance with 10 CFR 73.56. Therefore, the January 2, 1996 cover letter to enforcement action (EA 95-170) is hereby corrected to remove the reference to the Director of Nuclear Security in the second full paragraph on page 2.

In accordance with 10 CFR 2 790, a copy of this letter will be placed in the Commission Public Document Room.
