Change 7 to Revision 18 of the Physical Security Plan and Change 1 to Revision 3 of the Safeguards Contingency Plan

Dear Commissioners and Staff:

Pursuant to 10 CFR 73.55(c)(9)(ii), PG&E is submitting Change 7 to Revision 18 of the Physical Security Plan (PSP) and Change 1 to Revision 3 of the Safeguards Contingency Plan (SCP) in accordance with 10 CFR 50.54(p). The changes address implementation and installation of a vehicle barrier system for Diablo Canyon Power Plant (DCPP).

PG&E submitted a summary description of the proposed vehicle control measures per 10 CFR 73.55(c)(9)(i) (Re: DCL-95-046, dated February 28, 1995).

Enclosure 1 proposes revisions to the PSP that clarify PG&E's commitment to meet 10 CFR 73.55(c)(8). A new Appendix "I" has been added to provide details of the vehicle barrier system.

Enclosure 2 includes the pages of the PSP incorporating the changes identified in Enclosure 1. Changes are indicated by side bars in the left margin.

Enclosure 3 identifies and describes changes to the SCP on the same topic.


