Dear Mr. Sholly:

This is in further response to your letter dated September 8, 1983, in which you requested, pursuant to the Freedom of Information Act, 16 categories of documents. This response deals with item 6 of your letter.

The documents listed on Appendix A are being placed in the Public Document Room (PDR), 1717 H Street, NW, Washington, DC.

Portions of the documents listed on Appendix B are being withheld from public disclosure because they contain unclassified safeguards information. The authority for withholding this information is found in Section 147 of the Atomic Energy Act (42 U.S.C. 2167). This information is being withheld from public disclosure pursuant to exemption (3) of the Freedom of Information Act (5 U.S.C. 552(b)(3)) and 10 CFR 9.5(a)(3) of the Commission's regulations. The nonexempt portions of these documents are being placed in the PDR.

Pursuant to 10 CFR 9.9 of the Commission's regulations, it has been determined that the information withheld is exempt from production or disclosure, and that its production or disclosure is contrary to the public interest. The persons responsible for this denial are the undersigned and for documents 1 through 3 on Appendix B, John Davis, Director, Office of Nuclear Material Safety and Safeguards; and for documents 4 through 6, the undersigned and Harold Denton, Director, Office of Nuclear Reactor Regulation.


