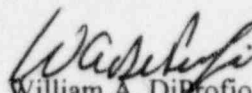
Subject: Seabrook Station Emergency Response Manual Revision 75 and Radiological

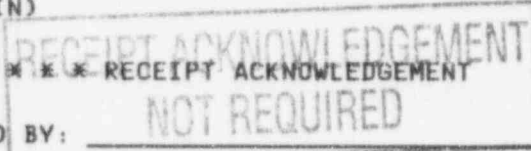
