Gentlemen:

This refers to the inspection conducted by Mr. C. R. Oberg and other members of the NRC staff during the period February 9, and 21-24, 1978, of activities authorized by NRC Construction Permit No. CPPR-147 for Wolf Creek, Unit No. 1, and to the discussion of our findings with Mr. J. O. Arterburn and other members of your staff at the conclusion of the inspection.

Areas examined during the inspection and our findings are discussed in the enclosed inspection report. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspector.

During the inspection, it was found that certain activities under your license appear to be in noncompliance with Appendix B to 10 CFR 50 of the NRC Regulations, "Quality Assurance Criteria for Nuclear Power Plants." The items of noncompliance and references to the pertinent requirements are identified in the enclosed Notice of Violation. Corrective actions to prevent recurrence of Item A.2. in the Notice of Violation, were completed prior to the conclusion of this inspection; therefore, a reply to this item is not requested.

Two new unresolved items are identified in paragraphs 5 and 7 of the enclosed report.

This notice is sent to you pursuant to the provisions of Section 2.201 of the NRC's "Rules of Practice." Part 2, Title 10, Code of Federal Regulations. Section 2.201 requires you to submit to this office. within 30 days of your receipt of this notice, a written statement or explanation in reply including: (1) corrective steps which have been taken by you, and the results achieved; (2) corrective steps which will be taken to avoid further noncompliance; and (3) the date when full compliance will be achieved.
