SUBJECT: NOTICE OF VIOLATION
(INSPECTION REPORT NOS. 50-338/92-10 AND 50-339/92-10)

This refers to the Nuclear Regulatory Commission (NRC) inspection conducted by Mr. M. Lesser of this office on March 22 - April 18, 1992. The inspection included a review of activities authorized for your North Anna facility. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the enclosed inspection report.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress.

Based on the results of this inspection, certain of your activities appeared to be in violation of NRC requirements as specified in the enclosed Notice of Violation (Notice). In addition, the enclosed Inspection Report identifies activities that violated NRC requirements that will not be subject to enforcement action because the licensee's efforts in identifying and/or correcting the violation meet the criteria specified in Section VII.B of the Enforcement Policy. A deviation from the Updated Final Safety Analysis Report was also identified. A Notice of Deviation is not being issued because the the problem was an isolated instance, prompt corrective action was taken and the issue was not of major safety significance.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice", a copy of this letter and its enclosures will be placed in the NRC Public Document Room.

The responses directed by this letter and the enclosed Notice are not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1930, Pub. L. No. 96-511.
