This letter refers to the safety inspection conducted by Messrs. J. C. Jang and J. J Kottan of this office on May 19-20, 1992 of activities authorized by NRC License No. DPR-50 at the Three Mile Island Nuclear Station, Unit 1, Middletown, Pennsylvania and to the discussions of our findings held by Messrs. J. C. Jang and J. J. Kottan with Mr. D. Hassler and other members of your staff at the conclusion of the inspection.

Areas examined during this inspection are important to public health and safety, and a described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, we noted that your staff improved its knowledge in the areas of effluent radiation monitoring system calibration methods. Furthermore, we noted that your staff prepared complete, detailed packages of data to resolve NRC's concerns (two unresolved items) regarding effluent radiation monitoring system calibrations. These efforts were noteworthy as described in Sections 3.0 and 4.0 of this inspection report. No safety concerns or violations of regulatory requirements were identified.
