This revised figure reflects changes to the DLC "Vital Area" concept for the BVPS-2 Refueling Water Storage Tank (RWST) as discussed with Mr. B. Manilli on August 15, 1984.

It is anticipated that this revision completes the upgrading of the Physical Security Plan to satisfy the requirements of 10CFR50 and 73.55, identified in Section 13.6 of the Draft Safety Evaluation Report.


