SUBJECT: IGSCC INSPECTION PER GENERIC LETTER 84-11

Re: Brunswick Steam Electric Plant, Unit 1

By letter dated December 5, 1984, you submitted the results of an intergranular stress corrosion cracking inspection of the piping completed during the recent shutdown for Unit 1. We have reviewed the results of that inspection as described by the letter and as presented by the CP&L staff in a meeting with the NRC on December 4, 1984. We find that the inspections conducted during this shutdown were in accordance with Generic Letter 84-11 dated April 19, 1984.

Based on our review, we conclude that Unit 1 may resume power operation until March 31, 1985 at which time a long refueling, modification and maintenance outage will begin. As discussed with your representative at the meeting, we expect CP&L to submit future inspection plans for Unit 1 thirty days prior to the next refueling shutdown which is scheduled to be about March 31, 1985.
