The violations underlying the first two allegations have been previously documented in Inspection Report Nos. 50-424/90-10 and 50-425/90-10 as non-cited violations. The third allegation did not represent a violation of NRC requirements. Based on the results of the investigation and our subsequent review, we plan no further action with regard to this matter. 
