SUBJECT: NOTICE OF VIOLATION (NRC INSPECTION REPORT NO. 50-302/92-10)

This refers to the inspection conducted by P. Holmes-Ray and R. Freudenberger of this office on April 4 - May 1, 1992. The inspection included a review of activities authorized for your Crystal River facility. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the enclosed report.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress.

Based on the results of this inspection, certain of your activities appeared to be in violation of NRC requirements, as specified in the enclosed Notice of Violation (Notice). Although the violation + s considered for discretion under the provisions of Section VII.B of the Enforcement Policy, discretion was not exercised because corrective actions initiated were not appropriate in that only long term corrective actions were established. Interim actions to ensure work instructions received appropriate reviews until the long term corrective actions could be implemented were not identified.

You are required to respond to this letter and should follow the instructions specified in the enclosed Notice when preparing your response. In your response, you should document the specific actions taken and any additional actions you plan to prevent recurrence. After reviewing your response to this Notice, including your proposed corrective actions and the results of future inspections, the NRC will determine whether further NRC enforcement action is necessary to ensure compliance with NRC regulatory requirements.
