Subject: **COMBINED EMERGENCY PREPAREDNESS (EP) INSPECTION NOS. 50-334/92-14 and 50-412/92-13**

Enclosed is the report of the June 9-10, 1992 inspection, by Mr. L. Eckert and others of this office, of Beaver Valley Atomic Power Station emergency preparedness (EP) and of the full-participation, annual EP exercise.

As discussed with members of your staff at the inspection exit, exercise performance demonstrated the ability to protect public health and safety. Exercise strengths included briefings by the Emergency Recovery Manager in the Emergency Operations Facility and proactive Operations Support Center equipment restoration efforts prior to TSC activation.

No safety inadequacies or violations of regulatory requirements were identified. However, exercise weaknesses were identified by the NRC in control of on-site damage control teams and in communication of field team data.

No response to this letter is required. Thank you for your cooperation.


