SUBJECT: CLOSEOUT OF ALLEGATION RI-91-A-0255 FOR OYSTER CREEK NUCLEAR GENERATING STATION

On September 27, 1991, the NRC received an anonymous allegation that an Oyster Creek security guard was observed having a seizure and has a history of seizures.

As a result, an allegation panel was convened on September 27, 1991, and the NRC decided to contact the licensee by phone to resolve the allegation. Based upon the licensee's investigation documented in a letter by G. Smith dated October 4, 1991, this allegation is unsubstantiated.

Based on the anonymous nature of the allegation, no response to the alleger is appropriate.

Documentation of the licensee actions to investigate this issue is attached.

This allegation is closed.
