As committed to in our November 20, 1984 letter, Florida Power Corporation (FPC) hereby provides three (3) originals and forty (40) copies of a supplement to our previously proposed Technical Specifications concerning:

1. Anticipatory Reactor Trips
2. Containment Isolation Valves
3. Reactor Coolant System Vents
4. Purge Valve Isolation

In this submittal, FPC has made changes recommended by the staff or provided an alternate method to satisfy staff concerns.

With respect to staff comments on Item 2, above, FPC will address isolation of the hydrogen purge system separately. Thus, the leak rate valves in question are not included in this submittal. Additionally, we have provided a few comments on the NRC proposed Standard Technical Specification concerning high point vents.


