During post refueling power ascension the 2C condensate pump seized upon starting. This resulted in a high motor current which reduced voltage on the 2A3 4160 volt safety related bus enough to cause the bus to strip and switch to its emergency diesel power source. These electrical transients caused sufficient loss of plant instrumentation to result in the plant operators deciding to initiate a manual trip. The cause of the condensate pump seizure was determined to be impeller failure. There was no adverse effect on the health and safety of the public.
