FEMA SUPPORT FOR NRC LICENSING OF LIMERICK GENERATING STATION

On May 8, 1984, the Federal Emergency Management Agency (FEMA) forwarded an interim finding report on the offsite radiological emergency response plans for the Limerick Generating Station. At that time, FEMA identified fifteen deficiencies in the plans and determined that the offsite emergency plans developed for incidents at Limerick were inadequate. Since that finding was submitted revised offsite emergency plans have been developed including plans for risk and support counties, municipalities and school districts. These plans have been entered into the record (following Tr 12,848) of the hearings on offsite emergency preparedness currently being conducted by the Atomic Safety and Licensing Board (ASLB) in Philadelphia, Pa. These same plans have also been provided to the NRC by the applicant in the course of preparing for the hearings.

In prefiled testimony submitted by FEMA to the Limerick ASLB, FEMA indicated that findings and determinations on the Limerick offsite plans would be provided in an expeditious manner upon request of the NRC. The purpose of this memorandum is to request FEMA to provide the NRC with findings and determinations as to whether the revised county and local emergency plans for Limerick are adequate and capable of implementation and whether the previously identified deficiencies are resolved by these plans. Although we muerstand FEMA may have already received copies of the referenced plans, a set of these plans is being furnished by the NRC for your convenience. A list of the plans being provided to FEMA is enclosed with this memorandum. Based on your December 25, 1984 telecon with Shelly Schwartz, I understand that FEMA has agreed to provide a supplemental interim finding for Limerick by March 1, 1985.
