IN TRANSMITTERS MANUFACTURED BY ROSEMOUNT

- REF: 1) TU Electric letter logged TXX-90238 from Mr. William J. Cahill, Jr. to the NRC dated July 18, 1990.
2) TU Electric letter logged TXX-91280 from Mr. William J. Cahill Jr. to the NRC dated August 5, 1991.

Gentlemen:

On March 9, 1990, the NRC issued Bulletin 90-01, "Loss of Fill-Oil in Transmitters Manufactured by Rosemount." Reference 1 provided TU Electric's response to the bulletin and delineated the program for Unit 1's compliance with the bulletin's requirements for operating reactors.

Reference 2, specified the corrective action to be completed for Unit 2. All Model 1153 Series B and D transmitters manufactured prior to July 11, 1989, have been returned to Rosemount. Some of the Model 1153 transmitters were returned for credit and replaced with the new Model 1154 Series H transmitters. The remaining transmitters have been refurbished by Rosemount with sensor modules manufactured after July 11, 1989. The letter "A" has been added to the serial number of the refurbished transmitters to provide identification. There are no Model 1154 Transmitters in Unit 2 which were manufactured prior to July 11, 1989.

All Rosemount transmitters installed in Unit 2 are either new or refurbished. This completes the corrective action for this bulletin for CPSES Units 1 and 2.




