Gentlemen:

This refers to the physical security inspection conducted by Ms. C. Abigail Evans and Mr. James A. F. Kelly of this office during the period November 13-16, 1984, of activities authorized by NRC Operating Licenses DPR-51 and NPF-6 for Arkansas Nuclear One, Units 1 and 2, and to the discussion of our findings with Mr. J. M. Levine and other members of your staff at the conclusion of the inspection.

Areas examined during the inspection included the security program audit, testing and maintenance, access controls, detection aids, and communications. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspectors. These findings are documented in the enclosed inspection report.

Within the scope of the inspection, no violations or deviations were identified.
