SUBJECT: ENFORCEMENT CONFERENCE (EA 92-109)

On June 19, 1992, representatives of Omaha Public Power District met with the Region IV staff in Arlington, Texas, to discuss an apparent violation concerning the protection of safeguards information. During the conference, the licensee discussed the circumstances leading to the event, the event discovery, the results of their investigation, and corrective actions. The licensee's investigation indicated that the event was not a deliberate or wilful act and that probably no actual loss or compromise of safeguards information occurred. The licensee provided a review of corrective actions taken or in the process of being implemented.






