You are required to respond to this letter and in preparing your response, you should follow the instructions in Appendix A.

We thank you for your letter of November 8, 1984 which was in reply to violations identified in Inspection Report 84-21. In January, Mr. Kenny will be expecting your schedule for the implementation of the program, and will follow up on your commitments as the schedule dictates.
