MINUTES

COMMISSION MEETING

June 2, 1992

The Commission Meeting began at 9:05 A.M. on Tuesday, June 2, 1992. Chairman Douglas L. Patch, Commissioner Bruce B. Ellsworth and Commissioner Linda G. Bisson were present. Also present were the Department Heads. The following matters were discussed.

1. Adoption of Minutes

A motion was made by Commissioner Bisson, seconded by Commissioner Ellsworth and unanimously approved to adopt the minutes of the May 25, 1992 Commission Meeting.

2. DR 91-105; New England Telephone Company

A motion was made by Commissioner Ellsworth, seconded by Commissioner Bisson and unanimously approved to ratify Executive Director Wynn Arnold's letter to the parties of June 1, 1992 granting New England Telephone Company's Motion to Postpone Hearings in this docket. Parties will be notified of the new hearing days.

3. DR 92-077; Public Service Company of New Hampshire (PSNH)

A. A motion was made by Commissioner Bisson, seconded by Commissioner Ellsworth and unanimously approved to ratify Order No. 20,495, which noted PSNH's request for a hearing on Commission Order Nisi No. 20,475 and directed that said Order Nisi will not take effect unless and until the Commission provides otherwise in a supplemental order.

B. A motion was made by Commissioner Ellsworth, seconded by Commissioner Bisson and unanimously approved to adopt the report and order mollifying Commission Order Nisi No. 20,475 regarding nuclear decommissioning increases. The order establishes a hearing date of June 29, 1992 at 11:00 A.M. to determine the relationship between increases in decommissioning charges ordered by the Nuclear Decommissioning Financing Committee and the PSNH Rate Agreement, as well as the orders issued in Docket No. DR 89-244.

4. DR 90-004; Southern New Hampshire Water Company, Inc.

Discussion took place concerning the proposed report and order which approves in part and denies in part revisions contained in Second Revised Tariff No. 8. A motion was made by Chairman Patch, seconded by Commissioner Bisson and
